The Grove Primary School recognises its responsibility to ensure the welfare and safety of children and young people and to comply with the General Data Protection Regulations 2018. You may wish to refer to our privacy notice on our website, which explains how we use your data, and your rights and responsibilities.

Your child's identity will not be disclosed without your consent and only if the photograph is used to celebrate individual success.
